

Purbakhola Rural Municipality has received a grant from Government of Nepal towards the cost of 11,89,467.40 (Eleven Lakhs Eighty Nine Thousands four hundred Sixty seven and Paise Forty only) **Supply and Installation of Solar Street Light** to apply part of the funds to cover eligible payments under the Contract for **Supply and Installation of Solar Street Light** items and contract Id no: EGP/SQ/GOODS/PRM/11/2076-77
2. Bidding is open to all eligible Bidders.
3. The Purbakhola Rural Municipality invites electronic bids from eligible bidders for the procurement of office solar system under Sealed Quotation procedures specified in Public Procurement Act, 2063 and Regulations, 2064.

7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 13:00 hours 2077/03/07 i.e. (2020 June 21) at the office of Purbakhola Rural Municipality, Purbakhola-3, Palpa. Bids must be valid for a period of 45 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of Rs. 30,000.00 (NRS. Thirty thousands only) which shall be valid for minimum 30 days beyond the bid validity period.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
