- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours 2077/09/19 at the office of Purbakhola-3, palpa. Bids must be valid for a period of 90 days after bid opening, and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of, which shall be valid for 30 days beyond the validity period of the bid. For bid security, bidder's should submit through bank guarantee only.
