2. Purbakhola Rural Municipality invites electronic bids from eligible bidders for the construction of *Construction of Community Conference Hall* under National Competitive Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

6. electronic bids must be submitted through PPMO website www.bolpatra.gov.np on or before on 12:00 hours 2077/01/09 (2020 April 21). Bids received after this deadline will be rejected.
7. Total Cost Estimate Amount : Rs.61,62,466.84 only
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours 2077/01/09** at the office of **Purbakhola-3, Palpa**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Rs 1,60,000.0**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **2077.05.09**). For bid security, bidder's should submit through bank guarantee only.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
