7. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp on or before 12:00 on 2077/02/09 i.e. (2022 May 22).

8. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 hours 2077/02/09 i.e(2020 May 22) at the office of Purbakhola Rural Municipality, Purbakhola-3, Palpa. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of Rs. 1,00,000.00(NRS.One Lakhs only) which shall be valid for minimum 30 days beyond the bid validity period [i.e. 2077/06/10].

9. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
