7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 hours 2077/02/02 i.e. (2020 May 15) at the office of Purbakhola Rural Municipality, Purbakhola-3, Palpa. Bids must be valid for a period of 45 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of Rs. 38,000.00 (NRS. Thirty eight thousands only) which shall be valid for minimum 30 days beyond the bid validity period.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
