Bidders, submitting their bid electronically, should deposit the cost of Rs 3000 of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 5. Pre-bid meeting shall be held at Purbakhola Rural Municipality at 15:00 hours , 2076/11/16.
- electronic bids must be submitted through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before on 12:00 hours 2076/11/27. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours 2076/11/27 at the office of Purbakhola-3, palpa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **2,50,000.00**, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2077.03.27). For bid security, bidder's should submit through bank guarantee only.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
